He succeeds Rusty Cunningham, who was named editor of the *La Crosse Tribune* — a position he also held from 1997 to 2001. Cunningham is a 36-year veteran of Lee newspapers and has been publisher of the River Valley Newspaper Group since 2004.

"I've thoroughly enjoyed spending more time in the newsroom since the editorship of the Tribune became vacant a couple of months ago," Cunningham said. "It has reinforced that my heart lies with journalism and covering a wonderful community."
